Eco-Cities - Zhifeng Yang 2012-10-15

As cities undergo vast changes due to industrialization, urbanization, and globalization, environmental considerations assume a growing importance in the urban planning processes of an increasing number of governments around the world. Several cities and regions around the world have already enacted policies that signal the emergence of a paradigm of sustainability in eco-cities planning. Providing an overview of urban ecosystem structure, function, and change, *Eco-Cities: A Planning Guide* addresses how to successfully accomplish eco-city planning that meets government requirements. It adds a new dimension to the understanding and application of the concept of urban sustainability, based on hypotheses about feedback between social and biogeophysical processes. Emphasizing integration, the first part of the book discusses various aspects of planning theory. It presents three innovative theories for socioeconomic models: a theory on the locational choices made by households and firms, an urban version of the stream continuum concept, and an application of metacommunity theory to the fragmented urban biota. These theories raise new urban planning questions and stimulate integrated modeling. The book also introduces urban planning modeling that uses existing social, vegetation, ecohydrological, and ecosystem service modules but is refined and

operated for enhanced cross-disciplinary integration and prediction. The second part of the book consists of several case studies of Chinese eco-cities covering a majority of the urban development patterns that offer in-depth examples of planning practices currently in use. Drawing on experimentation, comparison, long-term measurement, and modeling, this fascinating guide helps readers better understand eco-cities and eco-landscapes as integrated, spatially extensive, complex adaptive systems. It lays a solid foundation for engagement between urban planners, researchers, educators, policy makers, and citizens as they work to adapt to changing environmental, social, and economic conditions.

The Architecture of Pica Ciamarra Associati - Antonietta Iolanda Lima 2019-04

Since 1970, based in an isolated building situated on the peninsula of Posillipo, Pica Ciamarra Associati (www.pcaint.eu) has acted as a laboratory of architectural and urban design which has gradually incorporated new members and new energies over the time: using a multidisciplinary approach, the roots of the architectural practice lie in the intensive theoretical and practical work begun in the early 1960s by Massimo Pica Ciamarra. Since then the practice has been marked by a continuous relationship with Le Carré Bleu Feuille internationale d'architecture and leading members of the cultural milieu of Team 10:

this has led to constant attention to everything that lies beyond form, to the relationship with contexts that also include non-spatial contexts, and to high levels of integration and dialectical discussion. According to Pica Ciamarra Associati, a design transcends the approaches of a single sector, providing simultaneous solutions to contradictory requirements, combining utopia and practicality. The poetics of the fragment: it mediates between architecture and the urban dimension; some designs also have the aim of becoming absorbed within a context as 'informed fragments'. This monograph is the result of an intensive period of work and consists of two interacting parts. It stems from research into the archive of the studio Pica Ciamarra and conversation with the members of the architectural practice. Organised diachronically, the book tells the long story, unfolding over a period of over fifty years of a team of Neapolitan architects and designers, who have maintained the lively spirit of the practice which is still geared towards the future. The textual and iconographic account tells a story and offers an interpretation that highlight the vibrant atmosphere of the studio, based on a consistency of thought and action, and fuelled by an interest in many different forms of knowledge. The contextualisation of the events related to the studio, as they unfolded over time, is wide-ranging, coherent and connotative.

Antionietta Iolanda Lima, professor of history of architecture at the University of Palermo, has always tried, through theory, teaching and design, to disseminate the importance of history which can embracing innovation and tradition to an equal degree, forming a new architectural language. According to her view of architecture, history and design are closely connected, a 'single entity' as is reflected by her career. Since the 1980s, her academic work has gained increasing importance, a way of avoiding narrow sectoral approaches in the training of future architects, offering a holistic stance of the history of architecture and an architecture that contributes to shaping critical thought and a thriving cultural life.

Most books on waterfronts deal with a relatively narrow collection of cities and projects; one might describe them as the 'top ten' list of waterfront revitalisation projects. For instance, Boston and Baltimore are now the stuff of waterfront redevelopment legend. *Waterfronts in Post-Industrial Cities* is a second generation waterfront publication which reflects on recent and contemporary developments. Amsterdam, Boston, Genoa, Sydney and Vancouver are successful examples of cities that faced considerable challenges in their revitalisation efforts. A Decision-centred View of Environmental Planning - A. Faludi

The author of this book takes a view of planning which centres around the decision-making process and offers a theoretical approach which takes practice as its starting point. Building on his earlier important work, *Planning Theory* (Pergamon URPS 1984, first edition, 1973), this book constitutes a further major advance in planning thought, synthesizing the influence of the British IOR School with the American 'rational planning model'. Going beyond previous 'generic' approaches, the work culminates in a consideration of theory and practice in the planning of all forms of environmental intervention.

Barcelona - Joan Busquets 2005

Barcelona is regarded as a prototype of a European Mediterranean city with a long urban tradition. It has undergone a specific process of historic formation: density and compactness of urban form, evolution by extension rather than by reform. A history of urban planning necessarily includes a summary of the territorial and urban experience, the physical

dimensions of the city that condition its cultural and economic development. This book centers on the construction of Barcelona, taking as its basis the most important planning operations and city projects, and drawing from diverse sources and phases. The local scale of many of the projects contrasts with the cosmopolitan aspirations that have made these interventions so innovative; including major projects for special events, such as the 1888 (World Exhibition), 1929 (Electrical Industries Exhibition) and 1992 (Olympic Games). New prospects are emerging from the recent European institutional framework, particularly changes in the economic system to a post-industrial phase. The urban planning history of Barcelona shows how the city has overcome major contradictions.

Beyond the Port City - Beatrice Moretti 2020

Portuality is a concept that has long been rooted in several urban centers. It denotes a territorial quality specific to those cities and developed through strong relationships with their own port. Beyond the Port City recognizes portuality as a specific condition and suggests that the city-port threshold could emerge as one major symbolic field of exploration. This unique threshold materializes along the margin between the two authorities, namely in that space where the city and the port are side by side. It is marked by an administrative boundary that

becomes an accumulator of transit: a fragmented space where the juxtapositions take sufficient shape to acquire a dimension and to be recognizable. This book updates the old city-port dichotomy and outlines a new vision in which the port city is a forma urbis affected by the speed of changing processes and influenced by the factors that are embodied in its territorial palimpsest.

Questo libro intende rimettere al centro dell'attenzione delle politiche territoriali e del progetto urbanistico il tema della qualità ecologica delle coste, intese come infrastrutture ambientali e di servizio per la rigenerazione dei contesti territoriali. The Architecture of Community - Leon Krier 2009-05-08
